## INFORMATION FOR RELEASE

- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child: 4/22/2022 and 4/25/2022
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 4/22/2022, CCDFS received a referral indicating that the child suffered a medical episode on 4/21/2022 while in the shower. The water turned hot, and she sustained burns. The child was transported to a local hospital for treatment. At the time of the referral the child was not identified to be in serious or critical condition. There was also no information available to establish suspected abuse/neglect, and the referral was coded "Information Only".

On 4/25/2022, CCDFS received information that the child was in serious condition at the time she was admitted to the hospital pediatric intensive care unit. There is a concern regarding supervision of the child at the time the incident occurred and an alleged delay in seeking medical treatment. Based upon the additional information, an investigation was opened.

F. The cause of the fatality or near fatality, if such information has been determined:

The cause of the near fatality is under investigation.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

8/29/2018 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with appropriate referrals based upon assessment, and were provided with brochures and information regarding community resources. The case closed.

2/19/2021 — A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with information regarding community resources and the case closed.

11/1/2021 - A referral was received and was coded "Information Only".

11/17/2021 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with appropriate referrals based upon assessment, and the case closed.

2/6/2022 - A referral was received and was coded "Information Only".

2/6/2022 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with appropriate services and referrals based upon assessment. The case closed.
