  CCDFS received a report that 5-year-old child was deceased as a result of a fire that destroyed the family's residence. At the time of the report there were no details available as to the cause of the fire. Although there was no information available regarding abuse/neglect concerns regarding the cause of the fire, there was information received regarding possible neglect by an adult caregiver.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

10/6/2012 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with information regarding community resources and the case closed.

6/19/2016 - A referral was received and was coded "Information Only".

8/11/2016 – A report was received alleging neglect, with additional information being received 8/19/2016. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The case closed.

4/4/2018 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found substantiated. The family received appropriate referrals and services based upon assessment, as well as brochures and information regarding community resources. The case closed.

8/28/2018 - A referral was received and was coded "Information Only".

3/14/2019 and 3/14/2019 – Reports were received alleging neglect. Upon conclusion of requisite investigation, the allegation in each respective report was found unsubstantiated. The family was found not to be in need of ongoing services and the case closed.

1/16/2020 - A referral was received and was coded "Information Only".

5/1/2020 - A referral was received and was coded "Information Only".

11/29/2021 – A report was received alleging neglect. During the course of the open case, a referral was received on 1/12/2022 and was coded "Additional Information". Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with referrals and services based upon assessment and the case closed.

3/3/2022 - A referral was received and was coded "Information Only".

3/22/022 – A report was received alleging neglect. The case remains open.
