 CCDFS received a report that the child's adult caregiver contacted 9-1-1 due to the child exhibiting signs of physical distress. Law Enforcement and emergency medical personnel responded to the residence. Upon arrival, the child was found to be unresponsive, and he was transported to a local hospital where medical assessment deemed him to be in critical condition. There is a noted concern of maltreatment.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

11/28/2019 — A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, allegations were found substantiated. Appropriate services and referrals were provided to the family. The case was closed with safety measures in place, and relevant family members being released into the care of the non-offending caregiver.

8/19/2021 - A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. The family was provided with information and brochures regarding community resources. The case closed.

8/19/2021 – Based upon the foregoing report, a companion report alleging neglect was opened for investigation. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. The family was determined not to be in need of services through CCDFS. The case closed.
