- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

  CCDFS received a report that, on 5/24/2022, emergency personnel responded to a local residence on a 9-1-1 call regarding a child who became unresponsive while the care of her adult caregivers. The child was transported to a local hospital. Upon medical assessment, the child was determined to be in critical condition and tested positive for a controlled substance. Concerns were noted that there was no available explanation as to how the child had come in contact with the substance.

The cause of the near fatality is under investigation.

11/13/2017 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was unsubstantiated. The family was not in need of services or referrals, and the case closed.

11/7/2018 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. The family was not in need of services or referrals, and the case closed.

1/26/2020 - A referral was received and was coded "Information Only".

2/12/2020 - A referral was received and was coded "Information Only".

9/25/2020 - A referral was received and was coded "Information Only".

1/20/2021 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. During the course of the open case, a report was received on 5/7/2021 alleging abuse. The same date, a companion referral was also made to a secondary case and was coded "Information Only". The allegations in the report were found unsubstantiated. The family was provided with referrals and services based upon assessment. The case closed.

6/27/2021 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based upon assessment, the family was connected with an appropriate community resource. The case closed.

10/21/2021 – A report was received alleging abuse. On 10/25/2021 a second report was received alleging abuse and neglect. Upon conclusion of the requisite investigation involving both reports, allegations of abuse and neglect were found substantiated with regard to one caregiver. The family was provided with appropriate services and referrals based upon assessment, and was actively engaged in services. The minor was deemed safe in the care of the non-offending caregiver, and the case closed.

4/17/2022 – A referral was received and was coded "Information Only".
