 CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call relating to an unresponsive child. The child was transported to a local hospital where medical assessment deemed him to be in critical condition. He was then transported to another local hospital for continued specialized care. A concern was noted due to a lack of explanation provided by his caregiver that would account for the child's condition.
