- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child: 9/9/2022
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: On 9/9/2022, CCDFS received a report that the child was medically determined to be in serious condition. It was reported that, on 9/7/2022, the child was exhibiting signs of physical distress and was subsequently transported via emergency medical response to a local hospital. The child was admitted to the hospital for ongoing care and treatment. The child is diagnosed with an underlying medical condition and there is a concern regarding the ongoing and overall management of the child's condition by his adult caregivers.

The cause of the near fatality is under investigation.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

2/24/2015 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. The family was provided with information regarding community resources, and the case closed.

3/12/2015 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

10/14/2015 – A referral was received and was coded "Information Only".

8/20/2020 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. The family was provided with an appropriate referral for services based upon assessment, and the case closed.

8/27/2021 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

11/21/2021 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with information and literature to assist them with their needs, as well as an appropriate referral based upon assessment. The case closed.

1/18/2022 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found substantiated. The case remains open with appropriate referrals and services being provided based upon assessment.

CCDFS has opened an investigation for this instance. Family assessment remains ongoing. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
