C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 12/1/2022, CCDFS received a report that emergency medical personnel in Moapa responded to a 9-1-1 call regarding an unresponsive child. Based upon assessment of the child, she was airlifted from Moapa to a Las Vegas area hospital for specialized treatment. Medical evaluation determined the child to be in critical condition, with poor prognosis. A concern is noted that the adult caregiver's explanation of the incident leading to the child's condition is not consistent with medical evaluation of the child.

On 12/4/2022, the child was pronounced deceased.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

1/18/1999 - A referral was received and was coded "Information Only".

10/4/1999 - A referral was received and was coded "Information Only".

2/21/2000 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, allegations were found substantiated. Based upon assessment, an informal case plan was completed, and safety interventions put in place. The case closed.

10/26/2004 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated.

12/3/2004 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

6/1/2018 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. Based upon assessment, an appropriate referral for services was made and the services were put in place. The case closed.

5/21/2019 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with a relevant brochure, as well as a community resource guide for informational purposes. The case closed.

10/12/2022 – The Division of Family Services (DCFS) received a report alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated, and the child was assessed as safe. The case closed.
