 CCDFS received a report that the child's adult caregiver observed the child exhibiting signs of physical distress.

 Emergency medical personnel was contacted. The child was transported to a local hospital where medical assessment determined him to be in serious condition. There is concern that the explanation provided for the child's condition may not be consistent with the medical evaluation of the child.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

8/31/2018 – A report was received alleging abuse. During the course of the open case, a referral was received on 9/10/2018 and was coded "Additional Information". CCDFS received another report by a second source on 9/10/2018 alleging abuse and the report was opened for investigation. Another referral was also received on 9/11/2018 and was coded "Additional Information". Upon conclusion of both requisite investigations, the allegations were found unsubstantiated. At the time of case closure, relevant family members were determined to be safe. The case closed.

9/11/2019 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with a community resource guide for informational purposes, and the case closed.

3/16/2022 - A referral was received and was coded "Information Only".
