The child was transported to a local hospital where medical assessment determined him to be in critical condition.

CCDFS has no prior CPS history for the foster parents in whose care the child was in at the time of the near fatality incident

CCDFS has the following prior CPS history for the child who is the subject of this disclosure and/or member of the child's family:

1/31/2018 – A report was received alleging abuse and neglect. Court action was initiated, and the child and another relevant family member were determined to be in need of protection. The allegations were found substantiated. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided to the family. A permanency plan was put in place. During the course of the case, referrals were received on 6/24/2019 and 8/27/2020 and each was coded "Information Only." The case remains open for ongoing referrals and services.
