- **C.** A summary of the report of abuse or neglect and a factual description of the contents of the report: CCDFS received a report that the child was admitted to a local hospital where the child was medically assessed as being in critical condition. The child was previously diagnosed with an underlying medical condition and there is a concern regarding the overall management of the child's condition by her adult caregivers.

- E. The date that the child suffered the fatality or near fatality: 2/7/2023
