 CCDFS received a report that the child's adult caregiver contacted 9-1-1 after discovering the child unresponsive.

 Upon emergency medical services arrival and assessment, the child was determined to be deceased. The child had underlying medical conditions, and a concern is noted regarding the overall management of the child's condition by his adult caregiver.
