CCFS has the following prior CPS history for this child or member of the child's family or household:

3/2/2015 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. Based upon assessment the family was offered services, however, the family declined. The family was provided with brochures and information regarding available community resources and services, and the case closed.

2/9/2016 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. The family was not in need of services and the case closed.

12/1/2020 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found substantiated. Concerns were addressed and based upon assessment the family was not in need of services. The family was provided information regarding available community resources and services, and the case closed.

7/21/2021 – A report was received alleging abuse neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. Based upon assessment an appropriate referral was provided to the family. The case closed.

4/10/2024 – A report was received alleging neglect. The case remains open.
