A summary of the report of abuse or neglect and a factual description of the contents of the report: 15-year-old female was taken to the hospital after being found unresponsive and reported to be severely intoxicated. Medical personnel were unable to maintain a stable airway and therefore had to intubate to preserve life. Youth reportedly consumed half a bottle of Fireball Whisky that was provided to her by an adult.
- D. The date of birth and gender of child: 12/4/2006: Female
- E. The date that the child suffered the fatality or near fatality: 12/30/2021
- F. The cause of the fatality or near fatality, if such information has been determined: Alcohol intoxication
