- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:  
A report was received on 8/1/2021 indicating that the youth was found unresponsive in his home and required resuscitative measures to include Narcan. Youth subsequently admitted to finding a pill in a baggie on the group and ingesting it, youth believed it to be Percocet. Youth was hospitalized to be monitored following life saving measures. He has since been discharged with no complications
- D. The date of birth and gender of child:  
11/19/2006; Male
- E. The date that the child suffered the fatality or near fatality:

- F. The cause of the fatality or near fatality, if such information has been determined:  
Overdose from a pill with unknown origin
