- A. Date of the notification to the child welfare agency of the death of a child:
9/6/2021
- B. Location of child at the time of death or near fatality (city/county):
Reno, NV; Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
On September 6, 2021, WCHSA received a report of a child near fatality. Child was brought into the emergency room 9/4/21. Family reports child was playing and became limp and unresponsive. Child was given Naloxone by a family member as it was believed he ingested opiates. When he was brought in, he was lethargic and oxygen was very low, he was admitted to the ICU. On 9/5/21, while in the ICU, child became unresponsive and limp again, was given Narcan and became responsive.
- D. The date of birth and gender of child:
2/9/2020; Male
- E. The date that the child suffered the fatality or near fatality:
9/4/2021
- F. The cause of the fatality or near fatality, if such information has been determined:
Suspected opiate overdose

3/2019: A referral was received and coded “Information Only”

4/2019: A report was received indicating that the children are continuously exposed to domestic violence, substance use in the home and the children are dirty. Upon conclusion of the investigation the allegations were found unsubstantiated.

8/2020: A referral was received and coded as “Information Only”

The case remains open, and the agency is providing supportive services to the family. Detective is assigned and working the case.
