A report was received on 09/29/2022 that a 17-year-old child was found deceased at his residence on 09/28/2022. His adult brother transported him to the hospital and he was pronounced deceased shortly after arrival. There is an ongoing investigation by the Medical Examiner's office and law enforcement.
