Tribal Land in Pyramid Lake, NV; Washoe County

Abuse/Neglect unknown: possibly death due to medical neglect. Autopsy performed 3/23/2024. ME advised multiple problems related to Vacterl Syndrome. No observed injuries. Toxicology and cultures still pending.

- E. The date that the child suffered the fatality or near fatality:
3/22/2024
- F. The cause of the fatality or near fatality, if such information has been determined:
Unknown: Possible medical
